# **RED BULL PROT**



**By DANIEL MOXON** MERCEDES boss Toto Wolff has called Red Bull's protest "petty" and "embarrassing" after George Russell beat reigning world champion Max Verstappen at the Canadian Grand Prix.

Red Bull challenged Russell's Sunday victory in Montreal for driving erratically committing unsportsmanlike and conduct behind the safety car, a claim which was rejected by the stewards.

Speaking at the launch of the new F1 movie in New York, Mercedes chief Wolff said: "It took team Red Bull Racing two hours before they launched the protest, so that was in their doing.

'You know, honestly, it's so petty and so small. They come up with some weird clauses, what they call clauses. I guess the FIA needs to look at that because it's so far-fetched it was rejected.

"You know, you race, you win and you lose on track. That was a fair victory for us, like so many they had in the past. And it's just embarrassing."

Russell's win in Montreal was a first of the season for Mercedes and the protest is the latest in a series of controversies involving the Brit and four-time world champion Verstappen.

But Red Bull boss Christian Horner said: "We saw something we didn't think was quite right. You have the ability to put it in front of the stewards and so that's what we chose to do. Absolutely no rearets.'
